COURSE DESCRIPTION

Program Overview

- This is a "Certification Transfer" course; which means basic operational training, skills, and knowledge must have been acquired through a full Saga mobile equipment course prior to enrolment.
- The focus of a "Certification Transfer" course is the legislative and regulatory requirements of the jurisdiction for which the certificate will be issued.
- The combination of successful completion of a Saga mobile equipment Operator Certification course and Certification Transfer course provides the basic training, skills, and knowledge necessary to operate the equipment within the jurisdiction where certification is being transferred to.
- In this course "mobile equipment" is interchangeable with "powered mobile equipment (PME)" as used in other jurisdictions.
- This course follows British Columbia's Workers Compensation Act, and Occupational Health and Safety Regulation.
- This program takes into consideration the guidelines and principals of the Canadian Centre for Occupational Health and Safety (CCOHS).
- This program provides the minimum requirements for the training of operators for mobile equipment and is intended to supplement a company's larger Health & Safety Management System.

Course Goals:

- The student should have an awareness of the various legislation, regulations and standards that pertain to mobile equipment in British Columbia.
- The student should understand the roles and responsibilities of employers and employees as they relate to the operation of mobile equipment in British Columbia.

Prerequisites

- Students must have a current Saga mobile equipment operator certificate.
- The student should have an awareness of the various standards that pertain to mobile equipment.
- The student should understand the importance of mobile equipment inspections and how to conduct the inspections safely.
- The student should be familiar with safe operating procedures for mobile equipment.
- The student should be familiar with different types of mobile equipment, their basic structural components, basic function, and potential hazards while operating mobile equipment and how to control those hazards.
- The student should have a basic understanding of the proper use of mobile equipment attachments and potential hazards associated with mobile equipment attachments.
- The student should have a basic understanding of the operation of the most common Mobile Equipment.

Certification:

- At the end of the course there will be a multiple choice, open-book exam, of which at least 80% correct must be achieved.
- Certificates of training issued by Saga Universal Training Corp. must be recognized by the employer.
- Certification Transfer certificates will be for the same equipment as the "Operator Certification" certificate presented to enrol in this certification transfer course.
- Certification Transfer certificates expire on the same date as the operator certification presented to enrol in this certification transfer course.

BRITISH COLUMBIA LEGISLATION AND REGULATIONS

- The British Columbia's Workers Compensation Act, and Occupational Health and Safety Regulations apply to every occupation, employment and business.
- The Occupational Health and Safety Regulation Part 16 defines "Mobile Equipment" as a wheeled or tracked vehicle which is engine or motor powered, together with attached or towed equipment, but not a vehicle operated on fixed rails or tracks.

Workplace Hazardous Materials Information System (WHMIS)

The federal laws relevant to WHMIS are: The Hazardous Products Act - this places duties on suppliers, who sell or import a hazardous material for use in a workplace in Canada, to provide supplier labels and material safety data sheets to their customers.

British Columbia WHIMIS Requirements (Provided for reference only)

<u>Sections 5.3 to 5.19 of British Columbia's OHS Regulation, the WHMIS Requirements,</u> apply to employers and workers in British Columbia with respect to controlled products used, stored or handled at a workplace.

<u>Guidelines G5.3-1 to G5.15</u>, <u>Workplace Hazardous Materials Information System</u> (<u>WHMIS</u>), provide additional clarification and are intended to assist in the application and interpretation of the *Workers' Compensation Act* and *OHS Regulation*.

Transportation of Dangerous Goods (TDG)

The purpose of the Transportation of Dangerous Goods (TDG) Act and Regulations is to promote public safety when dangerous goods are being handled, offered for transport or transported by road, rail, air, or water (marine). TDG also establishes safety requirements. The Act and regulations are administered by Transport Canada's Transport Dangerous Goods Directorate.

British Columbia TDG Requirements (Provided for reference only)

The provincial program harmonizes provincial and federal requirements for transportation of dangerous goods on B.C. highways, including provincial ferry routes, through the following regulations.
